

SW1/4 NE1/4: WPA NOTES FOR THE E1/4 OF SECTION 34-T88N-R12W DATED 5/28/1941 INDICATES A STONE AT THE 1/4 1/4 BEING 3961.9' EAST OF THE W1/4 CORNER, FOUND REBAR WITH 2" ALUMINUM CAP AT SAID W1/4, FOLLOWED SPARCE FENCELINE TO THE EAST SAID DISTANCE AND PROBED, DUG A HOLE AND FOUND A LARGE LIMESTONE APPROXIMATELY 2.5'x1.5' IN SIZE, STORED MEASUREMENT ON HIGHEST POINT NEAR THE CENTER OF SAID STONE, ACCEPTED STONE AS CORNER AND TIED OUT.
