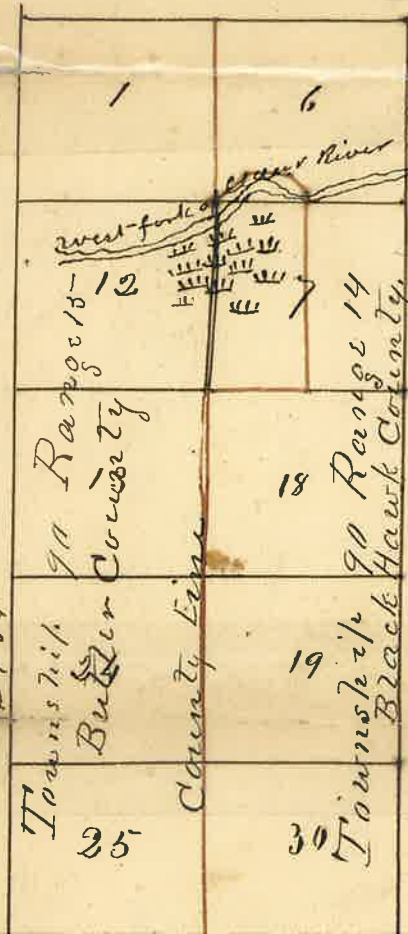

According to a commission from the County Court
of Black Hawk County State of Iowa authorizing me
to view (on the 23^d day of Aug 1859) a County Line Road
Road petitioned for by L. L. Corwin & Al commencing
at the S.W. corner of Sec 31 T 90 R 14 Thence North to the
North Line of said County, Having viewed



the route as required by Commission
I find it feasible and I believe that
the petitioners will be much benefited
by said road. I have therefore surveyed
and plotted
said road which I herewith return
together with field notes as follows.
Viz commencing at the road East of the
S.W. corner of Sec 31 T 90 R 14. Thence
North ^{18°30'} 18°30' west - 40 Rods or to 40 feet - on
the west line of Sec 31 T 90 R 14 Thence North
on said Line 200 Rods. Thence East - 26 Rods.
Thence North on a line parallel with said
line - 40 Rods Thence N 47½° W 41 Rods
to the N.W. Cor of Sec 31 T 90 R 14. Thence
North on said Line to the North Line of said County.

Black Hawk and State of Iowa, are held and firmly bound unto the County of Black Hawk
in the sum of one hundred dollars for the payment of which, well and
truly to be made, we bind ourselves, our heirs, executors, administrators, and every of them, firmly by these presents.

THE CONDITION OF THE ABOVE OBLIGATION IS SUCH, That, whereas, Clinton Bozarth
and others have ~~has~~ this day made application by petition, to the
County Court of said County, to appoint a commissioner to view and locate a road, called The Butler and
Black Hawk County Line Road

NOW, If the said road shall be established according to law, and the same becomes a public highway, in accordance with the statute
in such cases made and provided, then this obligation to be void: otherwise, to be and remain in full force and virtue.

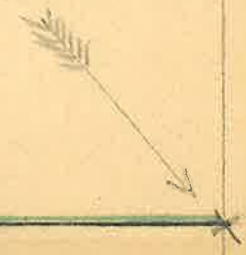

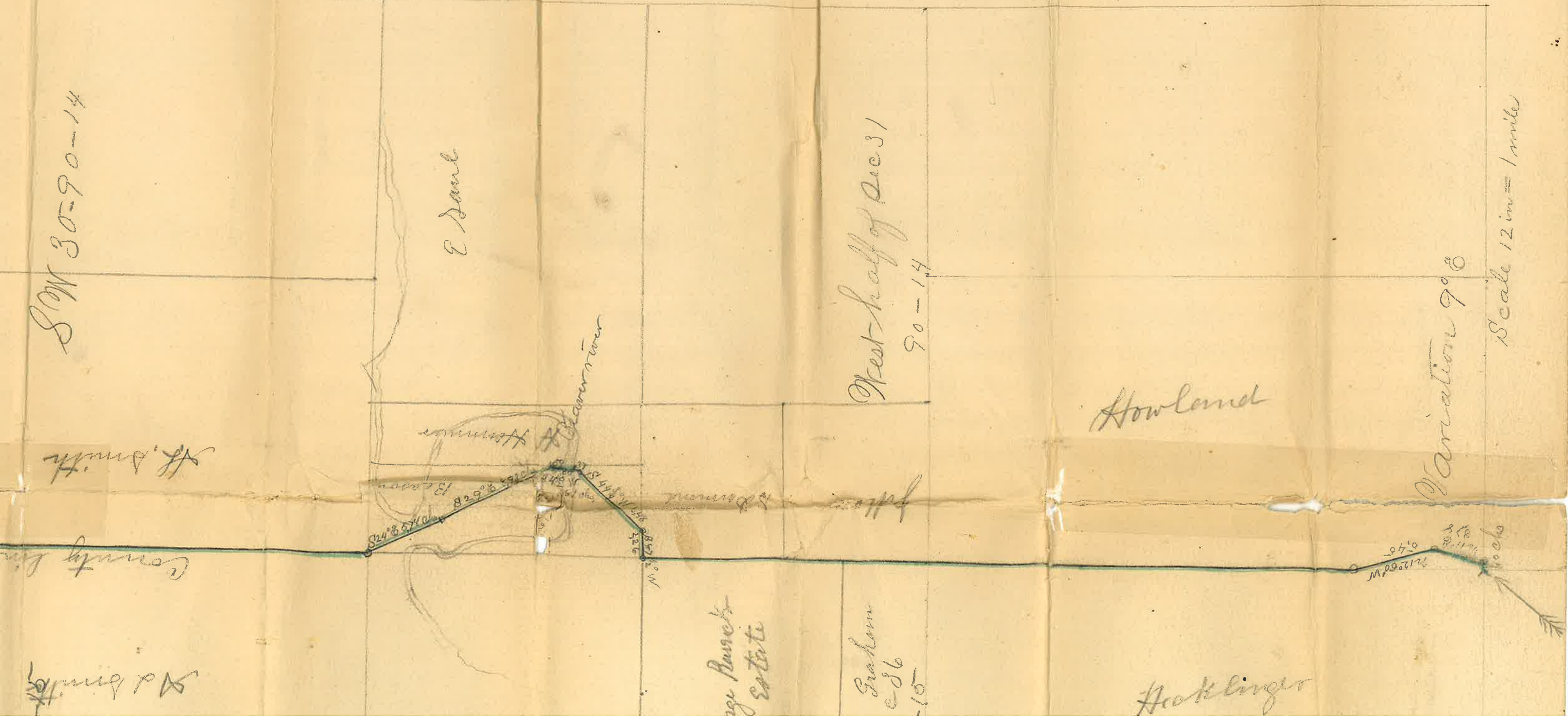
