of roads, inconsistent with the establishment of the
above road, be and they are hereby vacated.

County Court of said County, to appoint a commissioner to view and locate a road, ~~called~~ on the County
line between Black Hawk and Buchanan

NOW, If the said road shall be established according to law, and the same becomes a public highway, in accordance with the statute
in such cases made and provided, then this obligation to be void: otherwise, to be and remain in full force and virtue.

County, State of Iowa authorizing me
to view (on the 13th day of April, 1868) and
locate if required a County Road
petitioned for by O. Dunton to commence
at the S.E. corner of Sec 25 Town 89 Range 11
thence north to the Barley and Independence
Road

Having viewed said route as required
by commission. I find it practicable and I
believe the petitioner will be much benefited
thereby and I would recommend that the
road be established. I have therefore stated
said route which I find by return togeth-
er with field notes as follows. To wit

Sec line three and three fourth miles to its
intersection with the Barley and Independence
Road
