


Township Eighty eight (88) north of Range
Thirteen (13) West - in said County:- And
that by an act of the Legislature of said
State of Iowa, Approved on the 28th day of
January 1837, Commissioners were ap-
pointed to locate a State Road from
Waterloo to Fort Dodge in said State,
and that said commissioners surveyed
said route, & located said road, & filed
their plat & field notes thereof in this
Court, as will more fully appear
by the files & records thereof, and that
said road, so established by said commis-
sioners, runs through the above mentioned
land belonging to the undersigned,
in such a manner as to materially
damage & injure the same, either
for sale or occupation to wit:- the
amount of One thousand Dollars
