The undersigned would respectfully
show to this Court. that he is a citizen
of said County, and the legal owner
of the following described land in said
County, to wit:— The South East quarter ($\frac{1}{4}$)
of the South East quarter ($\frac{1}{4}$) of Section Six (6)
Township Eighty eight (88) North of Range
Fifteen (15) West— in said County:— And
that by an act of the Legislature of said
State of Iowa, Approved on the 28th day of
January 1857, Commissioners were ap-
pointed to locate a State Road from
Waterloo to Fort Dodge in said State,
and that said Commissioners surveyed
said route, & located said road, & filed
their plat & field notes thereof in this
Court, as will more fully appear
by the files & records thereof, and that
said road, so established by said commis-
sioners, runs through the above mentioned
land belonging to the undersigned,
in such a manner as to materially
Damage & injure the same, either
for sale or occupation to wit:— The
amount of One Thousand Dollars
