Ordway and others as follows to wit, Commencing at the N. E. Corner of section no. 24 or S. E. corner of section no. 13 in Township no. Eighty Nine (89) North of Range no. Thirteen (13) West of 5th P. M. in Black Hawk County Iowa thence running north to north East corner of said Township.

I found said route practicable for a public high way and would recommend its establishment as such
