Now if the said A. H. Longmire & D. R. Plant & M. G. Taylor

shall pay all expenses which may accrue in the ^{charge} ~~extension~~ of said road, in case the same
 shall not be established a public highway, then this bond to be void, otherwise to remain
 in full force and effect.
