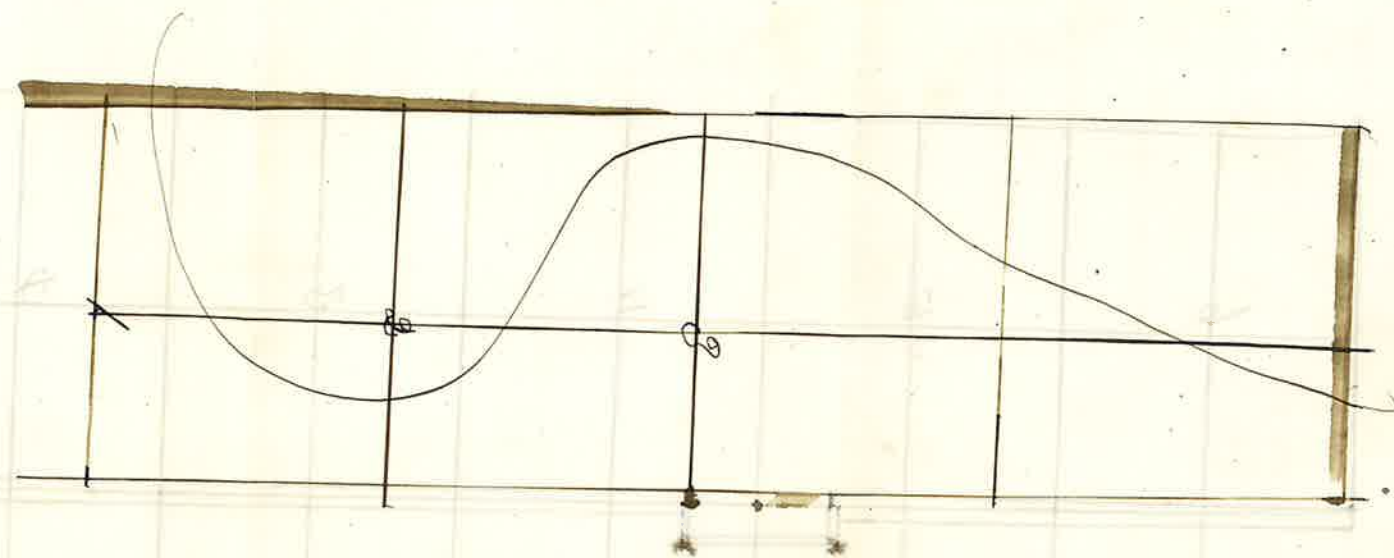

31. 1865— R. S. Wooster

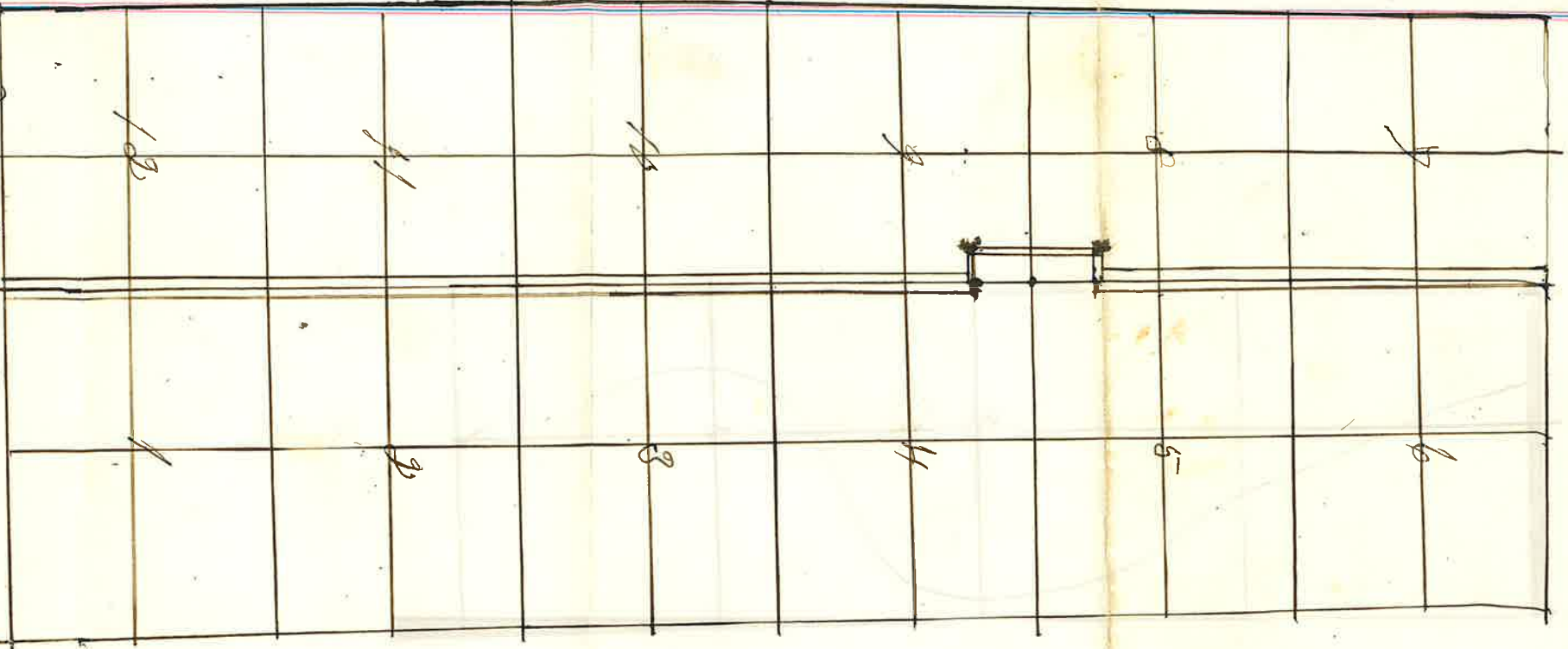

 shall not be established a public highway, then this bond to be void, otherwise to remain

To the Honorable Board of Supervisors,
and County Engineer of Black Hawk County:

The undersigned being residents of Fox Township, Black Hawk County, Iowa, respectfully petition your Honorable Body to change the public highway which runs east and west through said township between the sections from 1 to 6 on the north side and the sections from 7 to 12 on the south side so that it will extend straight west from the northwest corner of the east half of the northwest one-fourth of section 9

and to vacate that part of the public highway which now commences at the

Northwest corner of the East half of the
Northwest one-fourth of Section 9, thence
south 20 rods, thence west 80 rods, thence north
20 rods to the northwest corner of said section 9,

and we further petition your Honorable Body to gravel said east and west road in Fox Township so that the residents in said sections 1 to 6 and in said sections 7 to 12 will have a road to market.
