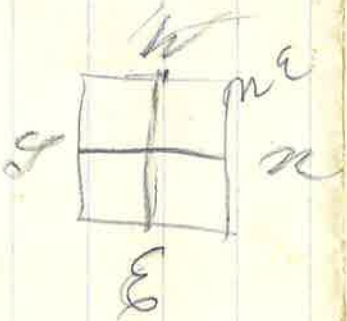

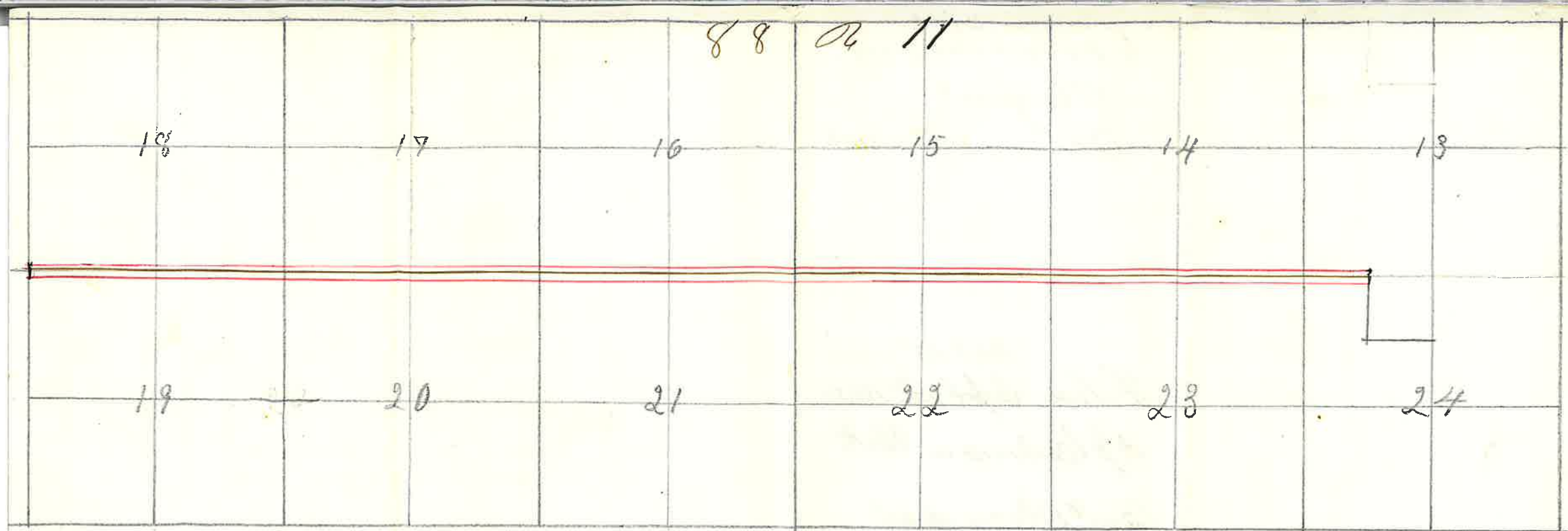

The above plat shows the location of a road petitioned for by John Tenient and others commencing at the North West corner of the North East Quarter of the North West Quarter of Section No. 24 in Township 88, R. 11 West thence running West on section line to the West Township line. The route for a public road is very good and a public high way as above described will be a great convenience a good many inhabitants. I would therefore recommend the establishment of the same as a Public high way.
