line of Sec 17 the 9th R 12 west - thence East-  
to East line of Sec 13 same Township & Range  
thence South to Sec 19 the 9th R 11 west -  
Then if the said Paul Ashme

shall pay all expenses which may accrue in the location of said road, in case the same  
 shall not be established a public highway, then this bond to be void, otherwise to remain  
 in full force and effect.
