Know all Men by these Presents, That we, *M. S. Cobb* & *L. O. Smith*, of the County of Blackhawk and State of Iowa, are held and firmly bound unto the State for the use of Blackhawk County, in the sum of *Fifty* dollars, for the payment of which, well and truly to be made, we bind ourselves, our heirs, executors, administrators, and every one of them, firmly by these presents.

The condition of the above obligation is such, that whereas *W. S. Cobb and L. O. Smith and others* has this day made application by petition to the Board of Supervisors of said County, to appoint a Commissioner to view and *locate* a road, to be called *the Rock Road*,

Now, if said *W. S. Cobb & L. O. Smith* shall pay all costs that may be adjudged against him by the Board of Supervisors, in accordance with the statute in such cases made and provided, then this obligation to be void, otherwise to be and remain in full force and virtue.

thence South (52 1/2') fifty two & one half
degrees East, thence nine chains eighty one
links to a stake at the intersection of the
old County Road fifteen chains fifty five
links East and three chains and fifty two
links South of the quarter section corner
between sections seven & eighteen in Town-
ship Eighty Eight North Range Twelve
West said proposed route being parallel
to the track of the Burlington
Minnesota Western Rapid Rail Road
and adjacent to the land owned by said
company for right of way.

The undersigned, having been appointed a Commissioner to view, and, if thought necessary, locate a certain Road in said County, petitioned for by

Wesley Cott and others, and known as the
Rock Road, would report as follows :

That, having been duly sworn, he found, upon examination, that it was expedient and necessary, for the accommodation of the public, that the road should be located as petitioned for.

Therefore, with the assistance of Myrrel as surveyor,
Geo. Smith & Charles Smith as chainmen,

~~women~~, who were all duly sworn, your Commissioner proceeded on the day set therefore, to-wit: the 27 day of March A. D. 1874, to lay out and locate said Road, and to distinguish the same by the proper marks, mounds, and stakes, in the manner prescribed by law, and in accordance with the Field Notes and Plat of Survey of the Road, which are herewith annexed, and which are made part of this report. See Plat & field notes of said location made by me John Ball Co. Surveyor
Your Commissioner is of the opinion, that the road will be of great convenience and utility to the public, and would hereby recommend its establishment.
