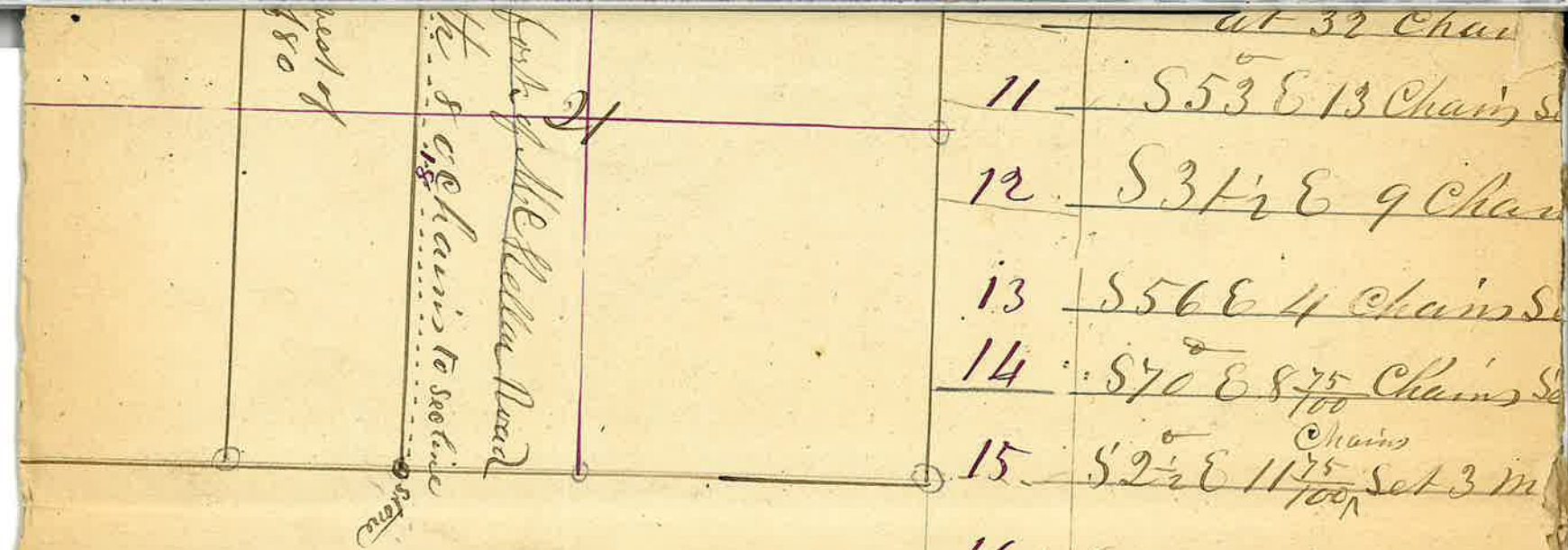

Know all Men by these Presents, That we, *Ardon McShellan*
& *Jennant Gay*, of the County of Blackhawk and State
of Iowa, are held and firmly bound unto the State for the use of Blackhawk County, in the sum of
no fifty dollars, for the payment of which, well and truly to be made,
we bind ourselves, our heirs, executors, administrators, and every one of them, firmly by these
presents.

The condition of the above obligation is such, that whereas *Ardon McShellan*
has this day made application by
petition to the Board of Supervisors of said County, to appoint a Commissioner to view and
locate a road, to be called *the McShellan Road*

Now, if said *Ardon McShellan* shall pay all costs that
may be adjudged against him by the Board of Supervisors, in accordance with the statute in such
cases made and provided, then this obligation to be void, otherwise to be and remain in full force
and virtue.

To the Honorable Board of Supervisors of said County :

The undersigned, having been appointed a Commissioner to view, and, if thought necessary, locate a certain Road in said County, petitioned for by Abelam McFeller and others, and known as the McFeller Road, would report as follows :

That, having been duly sworn, he found, upon examination, that it was expedient and necessary, for the accommodation of the public, that the road should be located as petitioned for. Having made on the 13th & 14th days of June 1871 a survey of the potential Route called by these parties the Hannum to go to the flat & fields notes of said Society See Run field notes therefore, with the assistance of Wm C. myself as surveyor, & Joseph Fullam & Joseph L. Lawrence as chainmen, Am C.

Abelam McFeller as owner, who were all duly sworn, your Commissioner proceeded on the day set therefore, to-wit: the 15th day of August A. D. 1871, to lay out and locate said Road, to name it a practical Route & its location being as follows and to distinguish the same by the proper marks, mounds, and stakes, in the manner prescribed by law, and in accordance with the Field Notes and Plat of Survey of the Road, which are hereto annexed, and which are made part of this report.

Your Commissioner is of the opinion, that the road will be of great convenience and utility to the public, and would hereby recommend its establishment.
