The undersigned respectfully petition that a Highway 66 feet wide, commencing at The N $2\frac{1}{4}$ of Section No 20 Township 87 North of Range 11 West-5th P.M. Beginning at the N.W. corner of the S $2\frac{1}{4}$ of the N.E. $1\frac{1}{4}$ Section 20 - 87 - 11

and running thence West on line of 40 13 $\frac{50}{100}$ Chains
Thence N 86° W $4\frac{30}{100}$ Chains 8 Chains S $7\frac{1}{2}^{\circ}$ W 75 links
Thence N $68\frac{1}{2}^{\circ}$ W 8 Chains Thence N 66° W $8\frac{25}{100}$ Chains
Thence N 81° W $6\frac{75}{100}$ ^{Chain} Thence West - Section line 12 $\frac{70}{100}$ Chains
South of the N $2\frac{1}{4}$ corner of Sec No 20
and terminating at intersection of Lanning Road

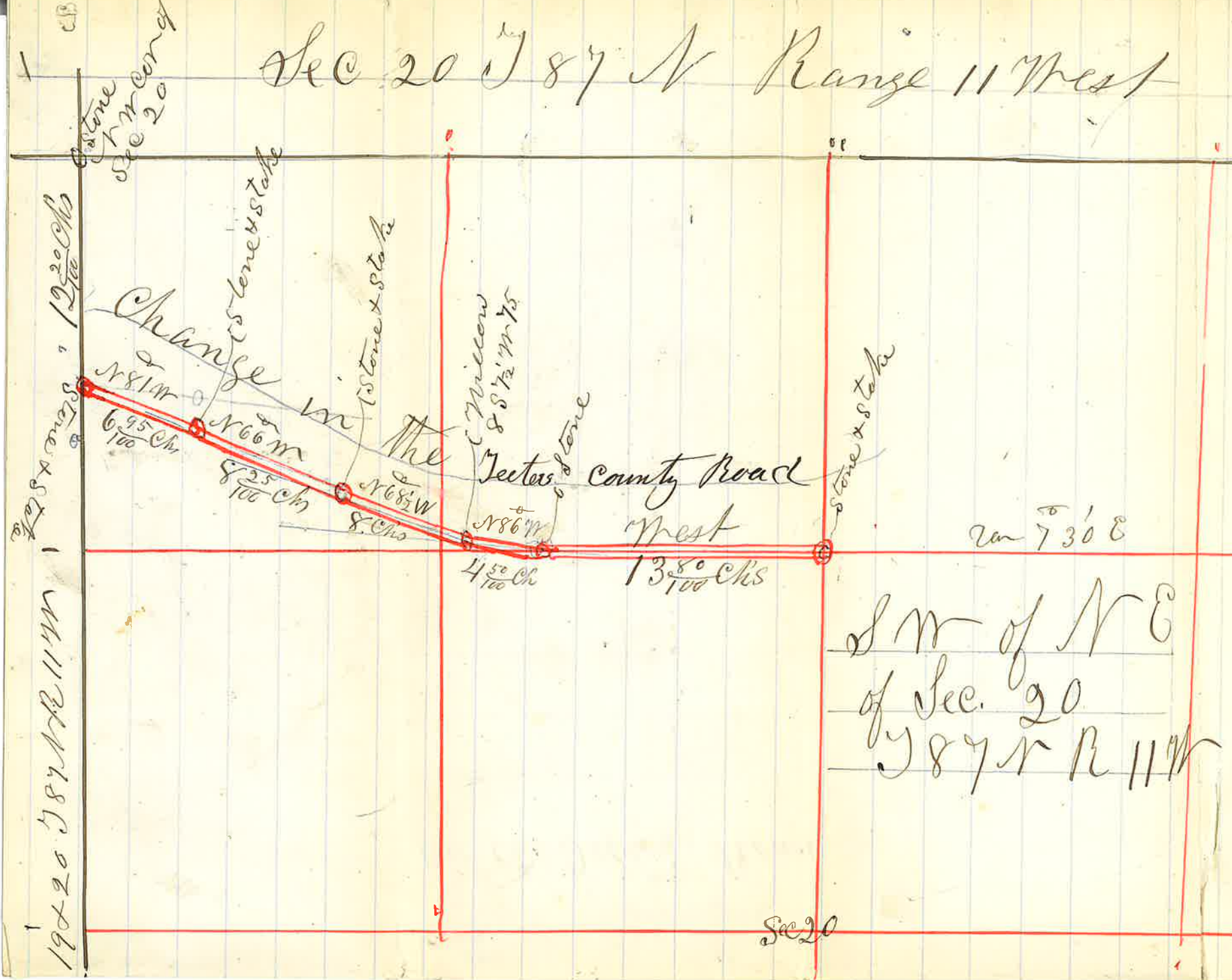

to grant and locate a road as follows to

East of the West line of said Section thence
thence to the West line forty five Rods South
of the North West corner of said Section
