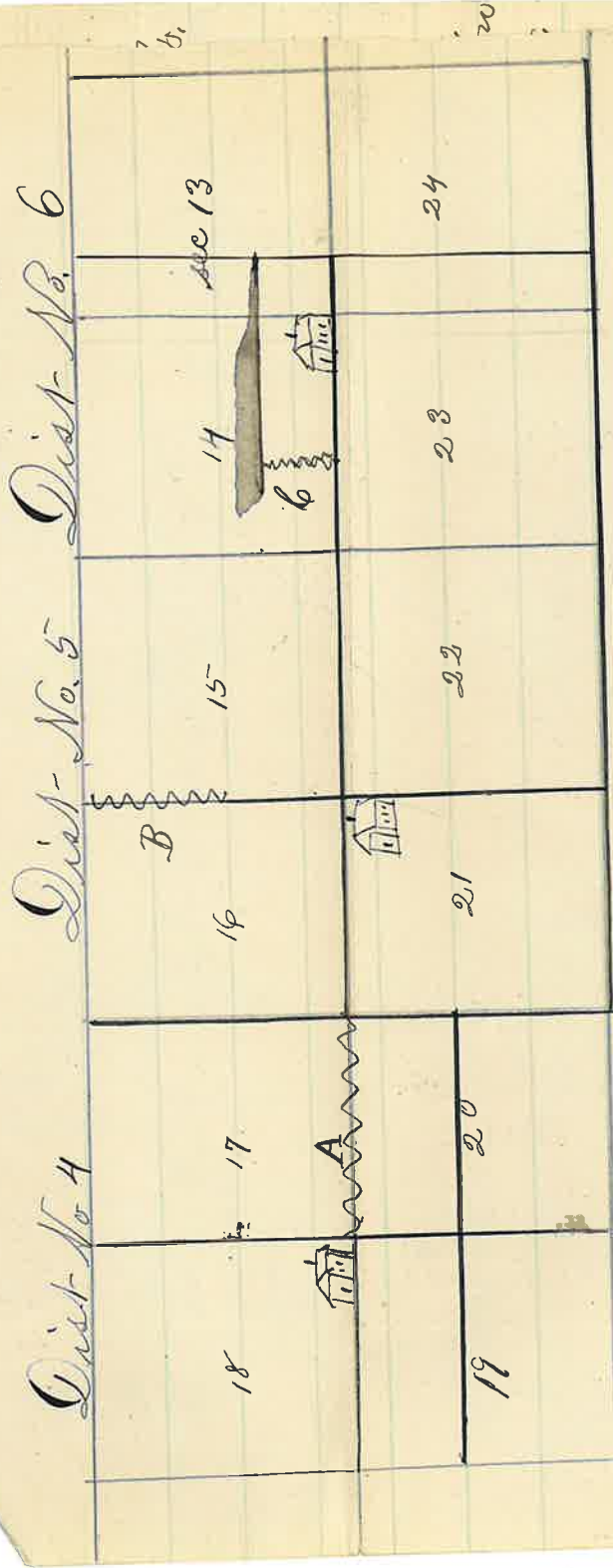
The School Board of Lester Township
