The undersigned ask that a Highway, commencing at the North West corner of Section number 19 in Township 89 North, 89 Range number 13 and running thence South on the Township line between Township 89 Range 12 and Township 89 Range 13 one half mile to the South West corner of the North West fractional quarter of said Section number 19 thence West one fourth mile North East quarter of Section 8 East quarter of Range 13 West 3/4 Sec. 19, number 24 Township 89 and terminating at Robinsons Street in Skellams addition to the City of Waterloo be located and called the "Basson Road" to be sixty six feet wide
