W. Fiegler's land extends to the river all of the above being in in Township 87 Range 12 North 6 PM be located and established

And we hereby represent that we are the owners in fee simple of all the lands affected by said proposed Highway, and hereby severally grant and give to the public the right of way over and upon our respective lands as above described, and waiving notice, relinquish all claims for damages by reason of such location.
