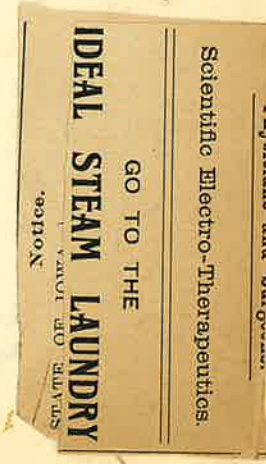

You are hereby notified, that you have been appointed a Commissioner to view, and, if required, to locate a County Road, petitioned for by the Board of Directors of Dist. Twp of Fox and others, and described as follows, to-wit:

Commencing at East Side of School House lot - about 17 Rods West of NE cor of Sec 7 + NE cor of Sec 8 Twp 88. N. Range 11 and running thence South Sixty (60) rods - Thence East to Section line between said Sec 7 & 8. 88. 11 Thence South to an section line to the South East corner of said Section Seven (7) + the South West corner of said Sec 8 - 88 - 11

Said Road to be three (3) rods wide

The said Highway being for the purpose of obtaining access to the School House in said Dist. No. Three (3) in the District Township of Fox in said County

You will therefore appear at the office of some Justice of the Peace, Notary Public, or other proper officer, and qualify according to law, and on the 16 day of June A. D. 1897 you will proceed to make an examination of the route above described. If, in your judgment, the above road is needed, or one in the vicinity of the route described, answering the same purpose, you may call to your assistance the necessary aid, and, each being duly sworn, cause said line to be accurately surveyed and plainly marked out.

You will connect your starting point with the nearest section corner or quarter post. When, however, there is a corner of a forty established in a permanent manner, more convenient, you may connect with it. In crossing a section line, NOTE that fact, and state the distance from the nearest section corner or quarter post. The plat of the survey to accompany the field notes should be on the scale of forty chains to the inch, with the section crossed by the survey laid off upon the like scale, and correctly numbered as per United States survey. Also, note all natural or artificial monuments or conspicuous objects, and the junction of streams. Also, report the number of bridges required, if any, and the probable cost thereof, on the proposed highway, as required by Chapter 89, Laws Nineteenth General Assembly. A strict compliance with these requirements is necessary, in order to establish a uniformity in the practice, and to enable the Clerk to correctly transcribe them for record.

You will report your proceedings, together with a correct plat of the proposed Road to this office on or before the 30th day of June A. D. 1897.

To the County Auditor of Black Hawk County:

The undersigned, appointed by you a Commissioner to examine into and report upon the expediency of locating

a road described in the foregoing commission, respectfully reports:

That in his judgment - a road three rods wide should be located as follows - Commencing at East side of School House lot - a point - about 230 feet West of NE corner of Sec 17 and at NW corner of Sec 8 Township 88 Range 11 and running thence South 42 rods to Georgianna Lake Thence Easterly 9 rods & 43 links to Georgianna Lake Thence Easterly 12 rods to L. P. line stake on Sec. line between sections 7 & 8 and thence fifty eight & one half rods South from the said L. P. & at 27 corners of said sections 7 & 8 thence South 26 1/2 rods on said section line to terminus at the South East corner of section 17 & the South West corner of section 18 all in Township 88 Range 11

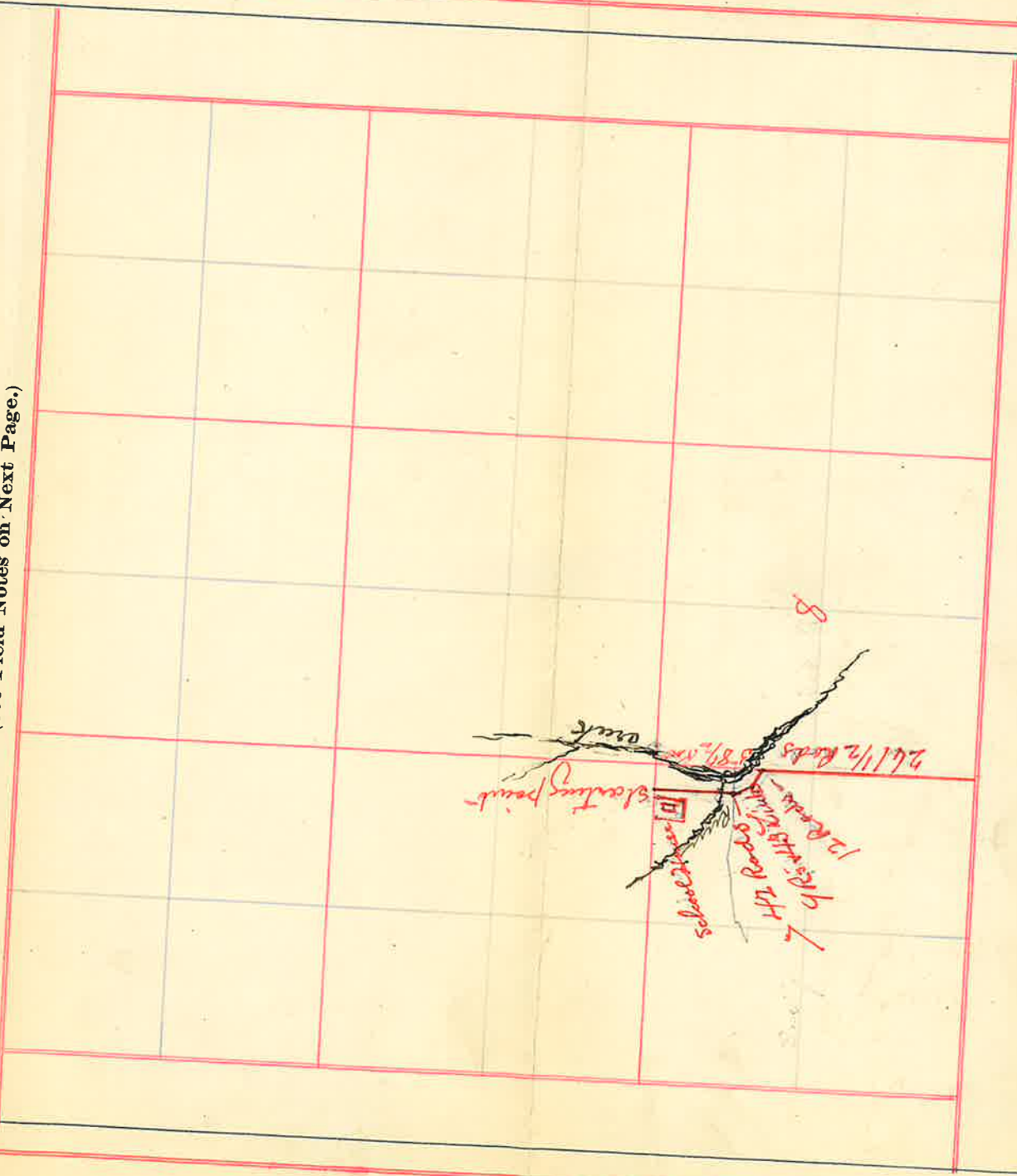
