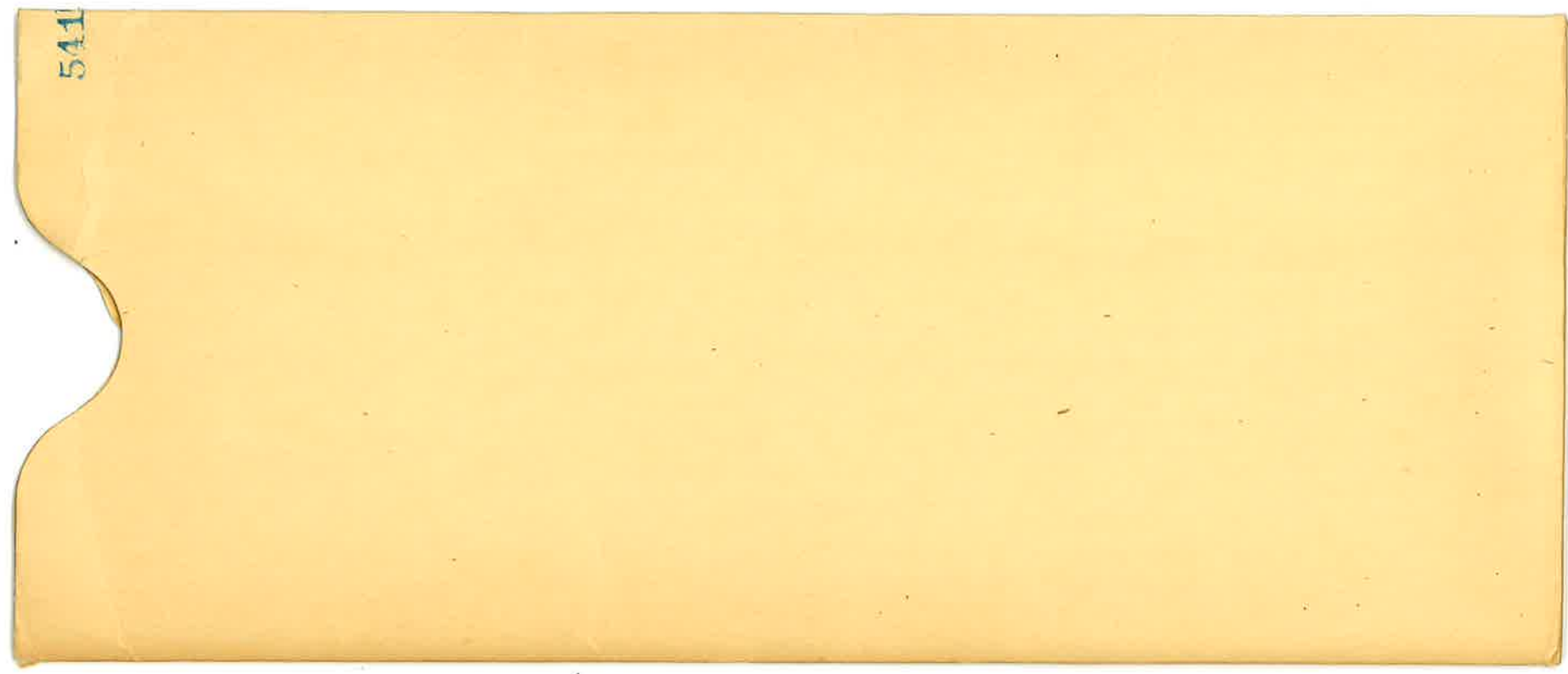

To the Board of Supervisors of Black Hawk County: IowaThe undersigned respectfully petition that a Highway 66 feet wide,

Commencing at the east end of the Crandall Road, which is 280 feet north of the center of Section 18-89-13 and 300 feet southwesterly from the center of the Waterloo & Cedar Falls Railway;

Thence southeasterly and easterly on a line parallel to and 300 ft from the center of the W.&C.F.Ry to the south line of the NE 1/4 of the SW 1/4 of said sec 17-89-13;

Thence S 75 E 20.55 ^{line} chains to the center of the SW 1/4 of the SW 1/4 of said Sec 17, it being the line between J.L. Bozarth and Mr. Knapp;

Thence S 80 E 30.03 chs to the east line of said Sec 17 at the NW cor. of the SW 1/4 of the SW 1/4 of Sec. 18 - 89-13 it being the east line of J. Riley's land and the corner between Mr Brees and Mr. Kretschmeier;

Thence S 64 E 43.00 chs to the N & S 1/4 line of Sec. 21-89-13, it being the line between Mr. Bailey and C.O. Lamson;

Thence S. 83 1/4 E. 13.38 chs to a point 53 feet from the centerline of the W. & C. F. Ry.

Thence S. Ely and Ely parallel to and 53 ^{feet} from the said W & C F Ry. across the lands of J. P. Hummel to a point 33 feet West of the E. line of said Sec. 21, and thence south 20 chs to the Waterloo and Cedar

And we hereby represent that we are the owners in fee simple of all the lands affected by said proposed Highway, and hereby severally grant and give to the public the right of way over and upon our respective lands as above described, and waiving notice, relinquish all claims for damages by reason of such location.
