Field Notes of Survey of Strawberry Avenue.

Strawberry Avenue commences at the SW corner of the NW $\frac{1}{4}$ of Sections 35-36, 89 N. & R. 13 W. 25 PM. in the center of the public highway known as the Eagle Center & Waterloo Road, running thence, with a width of 66 feet, ^{due} east 30 chains to a point 10.24 chains due west of the center of said Section 35, thence north $\frac{1}{2}$ mile intersecting the north line of said Section 35 at a point 10.31 chains west of the NE corner of the said NW $\frac{1}{4}$ of sections 35-36, all of which is shown in the accompanying plat, said measurements being made in and along the center of said road or Avenue.
