Contract

Know all men by these presents; That W. J. Rounds of Cedar Falls Ia. as the first party, has this date entered into a contract & agreement with E. B. Hall, William A. Clever, Mrs. E. C. Pohlson, and A. Merrill, as the second parties, as follows: The said first party hereby agrees to deed a sufficient number of feet in width from the extreme western terminus of 19th Street to half-section line road running South and North through section No 14 Township 89th North Range No 14 West of 5th P. M. Black Hawk Co Iowa, so as to correspond in line with 19th Street of the City of Cedar Falls Iowa, in consideration of the said second parties hereby granting privilege to the said first party to tap water ^{can} with taps at such places as the said ^{first} party designates.

And both of the said first & second parties hereby agree as a part of the consideration of this contract to deed in common a tract of land to the public to be used for highway or street purposes, as follows: - Commencing at the intersection of the South line of 19th with the West line of Normal Street in the City of Cedar Falls Iowa; thence west along the South line of said 19th Street to city limits of said Cedar Falls Iowa as a place of beginning; thence West 80 Rods to half-section line road running South & North through section 14 Township 89th Range 14 West; thence north 60 feet; thence east 80 rods to the City limits; thence south 60 feet to place of beginning all in section 14 Township 89th north Range 14 West P. M.

Gentlemen:-

We, the undersigned residents and tax payers of Black Hawk County, Iowa, and owners of property along the line of the proposed improvement, hereby petition your Honorable Body to lay out and establish a public highway upon the following described real estate in said county, to-wit:- Commencing at the intersection of the south line of Nineteenth Street with the west line of Normal Street in the city of Cedar Falls, Iowa; thence west along the south line of said Nineteenth Street to the city limits of the said Cedar Falls, Iowa, as a place of beginning; thence west eighty rods to the half section line road running north and south through Section 14, Township 89 North, Range 14 West; thence north sixty feet; thence east eighty rods to the city limits; thence south 60 feet to place of beginning; all in section 14, Township 89 North, Range 14 West of the 5th P. M.
