DESCRIPTION FOR NEW ROAD

A 4 rod road the centerline of which is described as follows:- Beginning at a point on the west line of Sec. 36-88-11 said point being on the centerline of Road No. 193 and 55.8 feet north from the 1/4 corner between Sec. 35 and 36-88-11, thence in a northeasterly direction, at an angle of 27° 04' with the west line said Sec. 36, 675 feet to a point on the north line of the S 1/4 NW 1/4 said Sec. 36 which ^{is} 310 feet east from the west line of said Sec. 36; thence running north parallel with ^{and} 310 feet east from the west line of said Sec. 36 to the south line of road No. 397-1/2 which is located on the south of and adjoining the school grounds in the NW 1/4 said Sec. 36.

All that part of Road No. 193 (said road running between Sec. 35 and 36 Fox Twp. Blackhawk County) which lies in the S 1/2 NE 1/4 Sec. 35-88-11 and north of a point 55.8 feet north of the SE corner ~~said~~ S 1/2 NE 1/4 said Sec. 35 except that part included in the new road which turns to the northeast at a point 55.8 feet north of the SE corner of the S 1/2 NE 1/4 said Sec. 35.

Vacate to *Richard Benorden*
