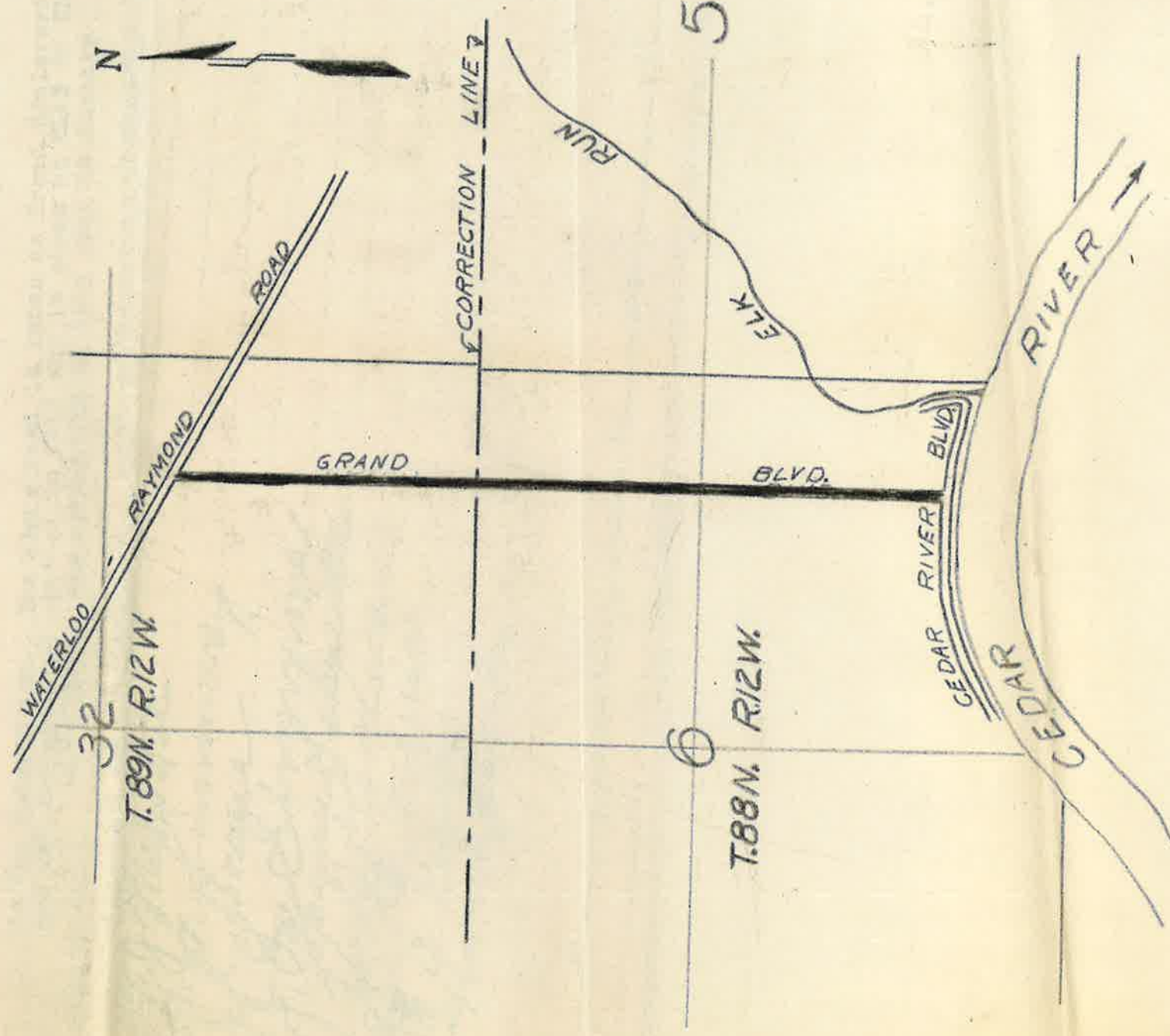

TO THE BOARD OF SUPERVISORS OF PLACK HAWK COUNTY:

The undersigned respectfully petition that a Highway sixty (60) feet wide, commencing at the center line of the Waterloo, Raymond Road, thence running

South through the Southeast Quarter (SE 1/4) of Section Thirty

Two (32), Twp. 89, Range 12, and also the Southerly through the

East one half (E. 1/2) of Section Six (6), Twp. 88, Range 12,

to the Cedar River. The above road is known as Grand Boulevard
and was surveyed and platted in 1913 and is shown on PLAT OF ELK
RUN PLACK. The centerline of said road is further

described as beginning at a point on centerline of Waterloo-Raymond

Road located approximately 853.5 ft. west of the East line of Section

32-89-12 thence continuing south for a distance of approximately

1.10 miles to an intersection with Cedar River Blvd. at a point

approximately 820 ft. west of the East line of Section 6-88-12.
and terminating at

And we hereby represent that we are the owners in fee simple of all the lands affected by said proposed Highway, and hereby severally grant and give to the public the right of way over and upon our respective lands as above described, and, waiving notice, relinquish all claims for damages by reason of such location.
