The following resolution was presented by Mr. Refshauge who moved its adoption, seconded by Beck:

WHEREAS a petition has been filed requesting the establishment of a road described as follows:

Beginning at a point 33 feet West of the Northeast corner of Section 1--89--14, Cedar Falls Township, thence West 3142 feet, thence South 485.10 feet, thence East 66 feet, thence North 419.10 feet, the thence East 2976 feet, thence North 66 feet to the point of beginning, the above described strip of land containing 5.40 Acres more or less and all situated in Black Hawk County, Iowa.

AND, WHEREAS, an easement has been given for the purpose of such road,

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors that said road petitioned for be and is hereby established in accordance with Section 4596 of the Code.
