Mr. Refshauge moved the adoption of the following resolution, seconded by Mr. Kline:

WHEREAS, the Board of Supervisors have been requested to establish road described as follows:

A tract of ground commencing Thirty-three feet (33) East of the center line of the Southeast Quarter (SE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Number 36, in Township Number 90 North, Range Number 14 West of the 5th P.M. as a place of beginning; Running thence North to the North line of said Forty (40) acre tract, thence West 66 feet, thence South to the South line of said tract, thence East on the South line of said tract to place of beginning.

and WHEREAS, an easement has been given to said Black Hawk County for such road, NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors that a highway as above described be and is hereby established in accordance to Section 5496 of the 1935 Code.
