The Board of Supervisors of the County of Black Hawk, in the State of Iowa, met in regular meeting at the Courthouse in Waterloo, County Seat of said County, at 9:00 o'clock a.m., pursuant to law, and to the rules of present: Chairman, Walter H. Bell, Frank W. Beck, John P. Biller, Mat Bornong, C. V. Kline, Geo. B. Miller, and Edw. Refshauge.

Mr. Kline moved the adoption of the following resolution, seconded by Mr. Refshauge:

WHEREAS, a petition has been filed, requesting the establishment of a road described as follows:

A strip of land sixty six (66) feet of even width, being thirty-three (33) feet on each side of a center line described as follows: Commencing at a point 1325.3 feet North of the Southwest corner of the Northwest Quarter (NW¹), NORTHEAST QUARTER (NE¹) Section 3, Township 87 North, Range 13 West of the 5th P.M. Cedar Township, and 44.25 feet East thence center line of the W. C. F. & N. Railroad, 34 minutes East a distance of 586.0 feet, and

and WHEREAS an easement has been given to Black Hawk County for such road, NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors that a highway as above described be and is hereby established in accordance with Section 5496 of the Code.
