The Board of Supervisors of the County of Black Hawk, in the State of Iowa, met in regular adjourned meeting at the Court House in Waterloo, County Seat of said County, at nine o'clock (9:00) a.m., pursuant to law, to the rules of said Board, and to adjournment. The meeting was called to order and on roll call there were present: Chairman, John P. Biller, Frank W. Beck, Mat Bornong, C. V. Kline, Geo. B. Miller, Edw. Refshauge, and Stanley Taylor. Absent: None.

Mr. Refshauge moved the adoption of the following resolution seconded by Mr. Taylor:

WHEREAS, the owners of all the land described below have agreed to severally grant and give to the public, the right of way over and upon their respective lands and said land having been already given to Black Hawk County by easement for said road, and

WHEREAS, the Board of Supervisors, after due consideration and investigation have decided that the highway herein described is a necessity and convenience,

NOW THEREFORE Be It Resolved by the Board of Supervisors that the following described road be and is hereby established as a local county road in Black Hawk County, established as of the 13th day of September, 1937:

The W 16½ ft. of the NE SE 5-90-14; the E 16½ ft. of the NW SE 5-90-14;

Ayes: Beck, Bornong, Kline, Miller, Refshauge, and Taylor.
Nays: None. Resolution declared adopted.
