The Board of Supervisors of the County of Black Hawk, in the State of Iowa, met in regular adjourned meeting at the Court House in Waterloo, the County Seat of said County, at 9:00 o'clock a.m., pursuant to law, to order rules of said Board, and to adjournment. The meeting was called to order and on roll call there were present: Chairman, Edw. Refshauge, Frank W. Beck, John P. Biller, C. V. Kline, Geo. B. Miller, Val Schmit and Stanley Taylor.

Mr. Taylor presented the following resolution and moved its adoption seconded by Mr. Schmit:

WHEREAS, full consent has been secured for land owners as required in section 4596 of the Code,

NOW, THEREFORE, IT IS RESOLVED that local county road be and the same is hereby established as follows:

Beginning at a point which is 1299.1 feet East, thence 5277.5 feet on bearing N 10 06' East, thence 595.55 feet on bearing S 89 59' East of the Southwest corner of Section 21, T. 88 N., R 12 W., thence a strip of land 33.0 feet in width on each side of the following centerline: South 56 50' East a distance of 1300.0 feet, thence on a curve of radius 5730 feet concave Northeastly, a distance of 315.5 feet, all adjacent to the South right of way line of the W.C.F. & N. Railroad and containing 2.44 acres more or less. The South Section line of Section 21-88-12 is taken as running due East and West in the description of this property.
