The Board of Supervisors of the County of Black Hawk, in the State of Iowa, met in regular adjourned meeting at the Court House in Waterloo, County Seat of said County, at nine o'clock (9:00) a.m., pursuant to law, to the rules of said Board, and to adjournment. The meeting was called to order and on roll call there were present: Chairman, Francis Messerly, Frank W. Beck, Carl R. Davis, David E. Keith, A. C. Newton, Edw. Refshauge and Val Schmit.

In accordance with prior action, the proposal to establish a road through sections 10-15-22 Township 88 Range 12 W was taken under consideration by the Board of Supervisors at ten o'clock (10:00) a.m. No one appeared to protest the establishment of said road. It was moved by Schmit seconded by Keith that a road be established over the following described tract of land, described center line:

Beginning at a point 35.0 feet north of the East Quarter corner of Section 22 Township 88 North Range 12 West of the Fifth P.M.; thence North 47° 35½' West 1130.9 feet; thence North 40° 18½' West 923.3 feet; thence North 50° 19' West 686.8 feet; thence North 55° 50½' West, 735.1 feet; thence North 44° 51½' West 522½.5 feet to a point on the North line of said Section 22, said point being 251.8 feet West of the North quarter corner of said Section 22; thence continuing North 44° 51½' West 417.5 feet; thence North 28° 56½' West 558.7 feet; thence North 18° 00½' West 589.1 feet; thence North 0° 13' West 1376.1 feet; thence North 9° 12' East, 632.3 feet; thence North 70° 40' East 1426.2 feet; thence North 19° 59' East 588.4 feet to a point on the North line of Section 15, Township 88 North, Range 12 West of the Fifth P.M., said point being 343.3 feet West of the North Quarter Corner of said section 15; thence continuing North 19° 59' East 37.0 feet; thence North 20° 26' West 1232.4 feet to a point on the centerline ~~thence North 20° 26' West 1232.4 feet to a point on the centerline~~ of highway Iowa 297. Note. The Bearing of the East line of the highway Note. The Bearing of the East line of the Northeast Quarter of said Section 22 is taken as due North. Motion carried.
