The Board of Supervisors of the County of Black Hawk, in the State of Iowa, met in regular adjourned meeting at the Court House in Waterloo, County S at of said County, at nine o'clock (9:00) a.m., pursuant to law, to the rules of said Board and to adjournment. The meeting was called to order and on roll call there were present: Chairman, Vincent Driscoll, Sr., Carl Davis, David Keith, Francis Messerly, Edw. Refshauge, Theo. S. Weber, and Earl R. Wray.

At ten o'clock (10:00) a.m., in accordance with prior action, the Board of Supervisors proceeded with hearing upon the vacation of County Road described as follows:

All that part of the Correction Line Road lying between the South 1/4 corner of Sec. 31 and the Southeast corner of Sec. 32, all in Township 89 North, Range 13 West of the 5th P.M.; Also, all that part of Black Hawk Road #402 lying in the Southeast 1/4 of Sec. 31, Township 89, North, Range 13 West of the 5th P.M.

No written protest were received and no one appeared to protest.

After due consideration it was moved by Keith, seconded by Davis, that the above mentioned road be and is hereby vacated, and that the following described highways be and are hereby established in lieu thereof:

Beginning at the South 1/4 corner of said Sec. 31 T 89 North, R 13 West of the 5th P.M.; thence North 84° 57' East 2040.8 ft; thence South 83° 54' East 616.6 ft to a point on the East line of said Sec. 31, which point is 114.1 ft North of the Southeast corner of Sec. 31, thence continuing South 83° 54' East 1018.1 ft. to a point on the South Line of Sec. 32, T 89 North R 13 West of the 5th P.M.; thence Easterly on the South line of said Sec. 32 to the Southeast corner of the said Sec. 32. Also: beginning at a point on the East line of Sec. 31 T 89 North R 13 West of the 5th P.M. where Road #241 intersects the Black Hawk Creek Road; thence running South along said East line of Sec. 31 to its intersection with the Correction Line Road as re-established above; which point of intersection is 114.1 ft. North of the Southeast corner of Sec. 31, T 89, North, R. 13 West of the 5th P.M.

Also: beginning at a point on the West line of Sec. 32, T 89 North, R 13 West of the 5th P.M. which point is 514.5 ft. North of the Southwest corner of said Sec. 32; thence South 87° 40' East a distance of 184.8 ft.; thence South 79° 50' East a distance of 180.0 ft to the West bank of Black Hawk Creek.

(The bearing of the South line of said Sec. 31 is taken as due East)
