The Board of Supervisors of the County of Black Hawk in the State of Iowa, met in regular adjourned meeting at the Court House in Waterloo, County Seat of said County, at nine o'clock (9:00) a.m., pursuant to law, to the rules of said Board and to adjournment. The meeting was called to order and on roll call there were present: Chairman, Vincent Driscoll Sr., Carl Davis, David Keith, Francis Messerly, Edw. Refshauge, Theo S. Weber, and Earl R. Wray.

Mr. Refshauge presented the following resolution and moved its adoption, seconded by Mr. Messerly:

IT IS HEREBY RESOLVED by the Board of Supervisors of Black Hawk County, Iowa that the following described property be and is hereby vacated, and the Chairman of the Board of Supervisors and the County Auditor are hereby authorized and directed to execute a quit claim deed on behalf of Black Hawk County, Iowa, conveying said described real estate to Andrew Hansen upon payment of One dollar and other valuable consideration:

All that part of the Northwest One quarter ($NW\frac{1}{4}$) of the Northwest one quarter ($NW\frac{1}{4}$) of Section three (3), Township eighty-nine (89) North, Range fourteen (14) West, lying South of the Illinois Central Railroad except the West Fifty feet (50.0') thereof and also except the following described right of way: Beginning thirty-three feet (33') East and Six hundred thirty-seven and seven tenths feet (637.7') South of the Northwest (NW) corner of said Section Three (3), thence South Three hundred seventy-five feet (375'); thence East Twenty-seven feet (27'); thence Northeastly to a point on the Southerly right of way line of the Illinois Central Railroad, which point is eighty feet (80') East of and perpendicular to the West Section line of the said Section three (3); thence Westerly along the Southerly right of way line of the Illinois Central Railroad to the point of beginning; Containing 0.693 Acres more or less, in Black Hawk County.
